Terms and Conditions

- 1) Maximum discount should be quoted on books of the Indian publication separately and foreign publication separately.
- 2) Tender fees:- The Tender fee (Non refundable) of Rs. 3600/- shall be paid by SBI Internet banking or other Bank Internet banking in State Bank MOPS in favor of COEP Technological University, Wellesley Road, Shivaji Nagar Pune 411005 (Account No. 11099464977 COEP Technological University Pune 411005)
- 3) Books in Indian reprints / Asian Editions / Paperback of foreign books should only be supplied if such economy editions are available.
- 4) Supplier should ensure the supply of all the books for which purchase order is issued.
- 5) Books should be supplied on door delivery basis only. Any type of packing, forwarding,

freight charges & any type of taxes will be borne by the supplier.

- 6) You will have to deliver the books within 45 days for Indian publications, and 60 days for foreign publications from the date of purchase order.
- 7) The quotations validity should be at least 120 days from the date of issue of the tender
- 8) Conversion rates will be applicable as on date of delivery of books.
- 9) Price proof for books will be accepted as per original Publisher's price/Authorized Indian distributors.
- 10) The damaged books will be replaced by you at your own cost.
- 11) It may be noted that, after receipt of quotations, this office is not bound to purchase all the quoted books from the enclosed list.
- 12) This office reserves the right to accept any quotations or reject any or all quotations without assigning any reason.
- 13) Delivery period is 45 days for Indian, and 60 days for foreign publications from date of issue of purchase order. In such case penalty for delay in proportion to the cost of books.
 - a) At the rate of 0.5% per week. maximum limit of 10% shall be charged in case of PO value is less than 2 Lakh.
 - b) At the rate of $0.5\,\%$ per week, maximum limit of 5% shall be charged in case of PO value is 2 Lakh and above
- 14) Books will not be accepted unless listed and with correct tittles, editions, publications, missing page numbers. Duplicate or pirated copy will not be accepted.
- 15) The Director, Knowledge Resource Center, COEP Tech university shall have fully Authority to change the number of titles of the books at any time before placing Purchase order.
