(One external audit by a distinguished industry expert/academician be mandated).

 Development. application and dissemination benchmarks/parameters for various academic and research activities of the

institution.

 Arrangement for feedback response from students, parents and other stakeholders on quality-related institutional processes.

Dissemination of information on various quality parameters of higher

education.

 Organization of inter and intra institutional workshops, seminars on quality related themes and promotion of quality circles.

 Documentation of the various programs/activities leading to quality improvement on campus.

 Development and maintenance of institutional database (through MIS) for maintaining, enhancing and demonstrating the institutional quality to the

 Preparation of the Annual Quality Assurance Report (AQAR) as per guidelines and parameters of NBA/NAAC, to be submitted to the Board of Governors of the Institute, after its presentation in Academic Senate.

The committee shall meet minimum Quarterly in an academic year and report the proceedings of the meetings (in the form of minutes of the meeting) to the Academic Council. The tenure of the committee shall be for the period of THREE Years, with effect from immediate date (i.e. date of the Circular), concluding on 30th June 2022 or until further orders.
